民族紛争は、国民統合の失敗から起こる集団間・組織間の暴力的対立であり、「国民国家の理念、自決権、自治権などが関わることから容易に分かるように、20世紀に入って生じるようになった類の紛争である」(猪口孝他編『政治学事典』弘文堂、2000年、1067頁)とされています。民族紛争に関する研究は、第一次世界大戦終結のころから始まり、その原因や処理に関する理論が急増したことも相まって、冷戦終結後に全盛期を迎えました。今日では、純粋に理論的なものから、民族的事例研究、統計学的分析、あるいはそれらを組み合わせた様々な方法論が研究に取り入れられています。
